frozen. First COVID hit, and I was stunned by how quickly it happened, it


felt like being frozen in time. Just when we start to thaw, the War in



"It feels great to be hosting our Old Seminole Heights Home Tour again," Tim Keeports, President of the Old Seminole Heights (OSH) Neighborhood Association was quoted. "We are one of Tampa's oldest neighborhoods and proud to showcase homes and businesses that demonstrate history, both old and new. This event gave us the opportunity to give back to the Gracepoint Coffee Shop via a \$1500 donation." In the past, we have shared articles about the CFO Tampa office being located in the OSH neighborhood. The area is on the National Registry and Tampa Historic District registry and comprises 325 "contributing structures" across 1,700 acres. One of the ways the neighborhood maintain community cohesion, is via the annual OSH Home Tour. The

 $22^{\mathrm{nd}}$  annual tour was April  $3^{\mathrm{rd}}$  and remains the longest-running in Tampa.

This year we featured seven homes (house #1 is above), one local business, and the Seminole Heights United Methodist Church (below) which is celebrating its Centennial. The tour gave attendees an insider view of the magnificent restoration work that encapsulates the history and

architectural character of the community. In addition to the tour, we

utilized the beautiful, historic Seminole Garden Center, which was dedicated in 1939 just prior to United States involvement in WWII as our ticket distribution and tour start point. Our self-guided walkable/bikeable tour featured historic bungalows, midcentury, and new-build homes dating from the late 1890s to the late-20<sup>th</sup> century. To help cyclists maneuver the neighborhood, Tampa Police Department was stationed at critical junctions and the local bike club provided maps to enhance safety for bikers and those on electric scooters. A portion of our tickets sales will provide a donation to **The**
